Micro-chipping | **Proof of micro-chipping is compulsory for registration purposes.** Council can't accept new registrations without your animal being microchipped and proof of microchipping

Desexing | Proof of desexing will be required to receive the reduced rate. Please contact your local Vet to assist with providing this proof.

Reduced Fee Categories | You may be eligible for a reduced fee if your animal fits into any of the following categories: (proof will be required for all of the following)

- Applicable Organisation Member. (VCA/FCC/GCC/DCC)
- Obedience Trained (must be with an applicable organisation)
- Over 10 years (proof required)
- Working Dog (proof required)

Pensioner Concession | To receive a pension fee on registration you must be the holder of any of the listed cards below:

- Department of Veterans Affairs' Repatriation Health
- Card specifying a War Widow or TPI
- Department of Veterans Affairs' Pensioner Concession card
- Centrelink Pension Concession Card

Note: Centrelink Health Care Cards are NOT accepted

Restricted Breeds | The Following restricted Breeds must be declared:

Dangerous / Menacing Dogs | If you fail to advise Council that you own a Dangerous Dog (Declared or Guard Dog) and/or a Menacing Dog at time of registration, you will be liable for penalties and/or court action.

Penalties | Infringements can be issued for:

- Failing to register or re-register your animal
- Your animal being at large day or night

Excess Animal Permits | Permits are required to house more than 2 dogs or 2 cats on residential premises
